WHEREAS, following the public hearing the Chickasaw County Board of Supervisors directed the Auditor to move one Deputy Sheriff from the Rural Services Basic Fund in the amount of \$127,957.00 to the General Basic Fund in the amount of \$97,181.00 and the General Supplemental Fund in the amount of \$30,776.00. The Board of Supervisors General Supplemental Fund budget was reduced by \$10,368.00. No other changes were made.
